Nevada Gaming Revenues and Collections

Win Revenue Summary – June 2013

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$792,496,546 for the month of June 2013. This amounts to a 4.81% decrease compared to June 2012, when licensees reported a gaming win of \$832,534,319. For the fiscal year (July 1, 2012 through June 30, 2013), gaming win has increased 1.81%.

Percentage Fee Collections for the Month of July 2013

The State collected \$43,356,931 in percentage fees during the month of July 2013\*, based upon the taxable revenues generated in June 2013. This represents a 13.26% (or \$5,076,228) increase compared to the prior year’s July, when percentage fee collections were \$38,280,703.
