Win Revenue Summary – August 2015

Nevada's nonrestricted gaming licensees reported a total "gaming win" of \$908,240,074 for the month of August 2015. This amounts to a 1.39% <u>decrease</u> compared to August 2014, when licensees reported a gaming win of \$921,016,033. For the fiscal year (July 1, 2015 through August 31, 2015), gaming win has decreased 1.17%.

Percentage Fee Collections for the Month of September 2015

The State collected \$51,608,939 in percentage fees during the month of September 2015*, based upon the taxable revenues generated in August 2015. This represents a 2.17% (or \$1,096,597) increase compared to the prior year's September, when percentage fee collections were \$50,512,342.
